The firm shall have valid and current trade license.

The intending tenderer shall have valid up to date clearance certificates of professional tax. If up to date PTCC is not obtained then receipted copy of tax deposit Challan from the date of PTCC last issued / obtained to the current year shall have to be produced.

- a) The firm shall have GST Registration Number.
- b) The firm shall have valid PAN.
