1. Prelude

a) As per decision of the authority & resolution of the meeting held on 13.09.2018 in the presence of head of the institutions of different secondary and H.S. schools of Chandernagore Municipal Corporation for installation of C.C. Camera in all vulnerable areas. C.C.TV cameras are required to be installed for the purpose of safety and security of students vide Memo No. 235-SSE/17 dated 26.10.2017 of Principal Secretary, School Education Department, Govt. of West Bengal.

b) This is a generalised NIQ seeking unit rate of all the items applicable in full set of C.C.T.V. system at any site. Analysis of requirement of C.C.TV cameras is yet to be done.

2. Items to be supplied :

b) Specifications for CAT 6 UTP Cable & Components as mentioned above

- i) Original equipment manufacturer should have manufacturing base in India.
- ii) Original equipment manufacturer should have direct presence/ Service Centers in India
- iii) Original equipment manufacturer should have toll free Number and warehouse in India.
- iv) Original equipment manufacturer should be a Company registered in India under the Indian Companies Act.
- v) Original equipment manufacturer Should offer 25 Years Performance Warranty based on successful site certification.
- vi) All the Cat 6 products should meet the CHANNEL performance of 100 Meters.
- vii) All Passive products should be RoHS compliant / directives.
- viii) All Copper UTP Components should be from the same OEM.

3. Scope of work :

- a) The bidders are requested to visit all the above mentioned schools and submit the unit rate of each items required for installation of CCTV cameras after self analysis of probable requirement of CCTV cameras to be installed.
- b) Requirement of all items is to be finalized after consultation with the successful bidder.
- c) The scope of work includes Supply & Installation inclusive of warranty for all items. The bidder shall be solely responsible for service of the items within 1 (one) month warranty period.
- d) All the works i.c.w. installation of CCTV cameras in different places of the schools mentioned above is to be completed within one month from the date of work order issued.
- e) The bidders are requested to submit the papers of N.I.Q within **21 days** (twenty one) from the date of publication of notice.

4. Submission of Tender

a) Technical bid : The intending bidder is required to submit a copy of the following :-

- i) PAN Card, GST Registration, I.T Returns for last 3 years.
- ii) Trade License & P. Tax Certificate.
- iii) Credential in similar nature of supply work.

b) Financial bid : The Bidder are required to submit unit rate of all 31 (thirty one) items mentioned in the No. 2 (a) in Rupees per piece. Work order to be awarded on bulk basis after finalization of requirement.
