Eligibility Criteria in case of Joint venture:

In case of a bidder applying through Joint venture , the Lead Member (Bidding firm) of such joint venture will be required to meet 60 % (sixty percent) of required Credential and each of the Joint Venture Members (Collaborating Firm) will be required to meet at least 30 % (thirty percent) of required Credential. Bid capacity of all the members in total should be at least 100 % (one hundred percent) of required Credential.

6) The Prospective Bidder shall have to execute the work in such a manner so that appropriate service level of the work is maintained during progress of work and a period of **3 (Three) year** from the date of successful completion of the work to the entire satisfaction of the Authority. If any defect / damage are found during the period as mentioned above, the contractor shall make the same good at his own cost to the specification at par with instant project work. On failure to do so, penal action against the contractor will be imposed by the Department as deemed fit. The contractor may quote his rate considering the above aspect. Refund of Security Deposit will only be made after successful maintaining of appropriate service level of the work as mentioned above for **3 (Three) year** from the date of completion of the work. Terms and Conditions of Chandernagore Municipal Corporation shall be treated as superseded. **Vide Order No- 592/1(125)/MA/C 10/3S-21/2013 dt. 28 day of October 2016.**

7) Site of work and necessary drawings may be handed over to the agency phase wise. No claim in this regard will be entertained.

8) **Earnest Money 2% of the estimated amount put to tender. It is to be submitted online. Tender fee, which is non-refundable, is to be submitted online**

9) The Bidder, at his own responsibility and risk is encouraged to visit and examine the site of works and its surroundings and obtain all information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice Inviting Tender, before submitting offer with full satisfaction, the cost of visiting the site shall be at his own expense.

10) The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the Department. The tender accepting authority of Chandernagore Municipal Corporation reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by an Tenderer at the stage of Bidding.

11) **Refund of EMD:** - The Earnest Money of all the **unsuccessful Tenderers** deposited in favour of "Chandernagore Municipal Corporation" payable at Chandernagore will be refunded online.

12) Prospective applicants are advised to note carefully the minimum qualification criteria as mentioned in 'Instructions to Bidders' stated in Section – 'A' before tendering the bids.

13) **Conditional/ Incomplete tender will not be accepted under any circumstances.**

14) **The intending Bidders are required to quote the rate online.**

In pursuance order of the Finance Department, GoWB vide no 4608-F(Y) dated 18.07.2018, the bidder shall be liable for submission of Bank Guarantee to the tune of 10% of the tendered amount in addition to the normal Security deposit of 10% in the event of the submitted financial bid being more than or equal to 20% less.

The subsequent issuance of Work Order shall be processed after submission of the Bank Guarantee, which shall be valid till the date of completion of contract and shall be subsequently refunded successful completion of the execution.
