### Tender notice for supply of Medicine Items for DISHARI

Sealed Tenders are invited from interested and reputed Firms/Agencies for supply of the Medicine items mentioned in the enclosed document for "DISHARI", a health service unit of Chandernagore Municipal Corporation situated at Khalisani, Bramhanpara, Chandernagore for the month of May 2022 to September 2022.

Rates of each item should be quoted at the right side of the enclosed format. However in some cases, the name of the company is being mentioned. Quoted rate should be inclusive of transport and all incidental charges including GST and others charges as prevailing update.

Tender should be submitted on or before **19<sup>th</sup> May 2022 within 12 noon** in the tender box of Chandernagore Municipal Corporation and it will be opened on the **19<sup>th</sup> May 2022 at 3 p.m.** at the Chamber of undersigned. Rate should be quoted clearly, avoiding any overwriting. The category of medicine should be clearly mentioned in the envelop (Viz Medical items, Surgical items, Pathological items).

The items are to be supplied as per requirement of Dishari on placing order from time to time. The accepted rate shall remain valid for the month mentioned herein before i.e. May 2022 to September 2022.

. In no circumstances, any request for subsequent increase in accepted rate shall be entertained during the aforesaid mentioned period.

The Tender Document (format) is available in CMC website ([www.chandernagoremunicipalcorporation.in](http://www.chandernagoremunicipalcorporation.in)).

In case of certain items as detailed in the enclosed list, where it is necessary to physically examine the items. The rate quoted by the tenderer shall be verified with specimen / sample and thereafter decision will be taken.

All the tenderers shall submit the following documents while submitting tenders.

- a) Latest Clearance Certificate of payment of S.T. & I. Tax.
- b) Document on drug License.
- c) Document on Enlistment Certificate (commonly known as Trade license ) issued by the local municipal body.
- d) Credential as to supply of medical items to elsewhere.
- e) GSTN NO. and PAN NO.

Tenderers or any authorized representative of the tenderer may remain present at the time of opening the tender. Absence of any document as mentioned above may prima-facie disqualify him in subsequent process.

The successful tenderer whose rate is accepted, herein before shall have to observe the following formalities.

1. To ensure supply within stipulated date mentioned in work / supply order.
2. To ensure supply strictly in terms of quality and quantity of specification / brand etc of the items question.

The authority in case of any deviation may impose fine which shall be deducted from the quoted amount of the bill as the case may be with intimation to the suppliers.

The authority also reserves right to reject any tender including the lowest one without assigning any reason whatsoever.
