If any defect / damage are found during the period as mentioned above, the contractor shall make the same good at his own cost to the specification at par with instant project work. On failure to do so, penal action against the contractor will be imposed by the Department as deem fit. The contractor may quote his rate considering the above aspect. There will be a 3 (Three) years defect Liability clause for successful maintaining of appropriate service level of work mentioned above.
